ORDER GRANTING COMPLAINANT'S MOTION TO CONTINUE HEARINGS AND MOTIONS TO A DATE AFTER OCTOBER 5, 2013; AND NOTICE OF RESCHEDULED PREHEARING CONFERENCE

On August 21, 2013, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (Complainant or HGEA/AFSCME), by and through its attorney, filed HGEA/AFSCME'S MOTION TO CONTINUE HEARINGS AND MOTIONS FOR TO A DATE AFTER OCTOBER 5, 2013 (Motion) with the Hawaii Labor Relations Board (Board), pursuant to Hawaii Administrative Rules (HAR) § 12-42-8(g)(3)(C).

The Declaration of Peter Liholiho Trask (Declaration) attached to the Motion represents that after email and/or telephone discussion with each of the Respondents' attorneys, the parties have agreed to further continue the Prehearing Conference, currently scheduled for August 26, 2013, at 10:00 a.m., and all other hearings scheduled in this matter to a date after October 5, 2013, and at the Board's convenience for further settlement purposes. The Board notes that as a result of the Board's Order No. 2930, Order Granting Complainant's Motion to Continue Hearings and Motions for 30 Days,

currently, the following are not yet scheduled: (1) hearing on Respondent Board of Regents' Motion to Dismiss in Lieu of Answer, and Respondents Neil Abercrombie, Board of Education, and Mark Recktenwald's Motion to Dismiss in Lieu of Answer; (2) deadline for Complainant to respond to the Motions to Dismiss in Lieu of Answer; and (3) a Rescheduled Hearing on the Prohibited Practice Complaint.
