On November 21, 2013, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO by and through its attorney Peter Liholiho Trask filed a MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON JULY 23, 2013 with the Hawaii Labor Relations Board (Board), pursuant to Hawaii Administrative Rules (HAR) § 12-42-44.

TAYLOR, P.E., Director, Department of Water Supply, County of Maui and COUNTY OF MAUI, (Respondents) by and through its attorneys Patrick K. Wong, Corporation Counsel, and Jennifer M.P.E. Oana, Deputy Corporation Counsel, filed RESPONDENTS' STATEMENT OF NO OPPOSITION TO COMPLAINANT'S MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON JULY 23, 2013.

HAR § 12-42-44 provides that any complaint can be withdrawn at any time prior to the issuance of a final decision and order thereon, upon motion and consent of the Board. Based on a


review of the record and consideration of the instant motion and the response thereto, the Board grants the withdrawal of the instant Complaint, with prejudice. This case is closed.
