ORDER GRANTING PETITION FOR INTERVENTION

On November 13, 2013, Petitioner UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (Petitioner or UHPA) filed a Petition for Clarification or Amendment of Appropriate Bargaining Unit with the Hawaii Labor Relations Board (Board).

On November 29, 2013, the Board issued a NOTICE OF RECEIPT OF PETITION FOR CLARIFICATION OR AMENDMENT OF APPROPRIATE BARGAINING UNIT; NOTICE OF DEADLINE FOR FILING PETITIONS FOR INTERVENTION; AND NOTICE OF BOARD CONFERENCE and established 4:30 p.m., December 18, 2013, as the deadline to file petitions for intervention.


On December 13, 2013, the BOARD OF REGENTS, University of Hawaii (BOR), by and through its counsel, filed a Petition for Intervention with the Board in this matter. The BOR alleges that it is a public employer under the Hawaii Revised Statutes (HRS) of Unit 07, and any decision rendered in this proceeding will affect its rights and interest in managing University affairs. The BOR alleges that its intervention in this proceeding would not broaden the issues nor delay the proceeding and will contribute to the development of a sound record.

At the Conference held on January 6, 2014, Counsel for UHPA indicated that they did not oppose the petition for intervention.


Based on the record and a review of the instant timely Petition for Intervention, the Board finds that the BOR is the public employer of the instant positions and that its interests may be impacted by a Board decision in this case sufficient to warrant its intervention. Accordingly, the Board grants the BOR's Petition for Intervention pursuant to Hawaii Administrative Rules (HAR) §§ 12-42-8(g)(14) and 12-42-9(e).


