ORDER GRANTING RESPONDENT'S MOTION TO
CONTINUE HEARING AND NOTICE OF STATUS CONFERENCE

On February 6, 2014, the Hawaii Labor Relations Board (Board) issued Notice of Hearing, Hearing Deadlines and Waiver of § 377-9(b), Hawaii Revised Statutes and § 12-42-46(b), Subchapter 3, Chapter 42, Title 12, Hawaii Administrative Rules giving notice that the Board hearing on the merits scheduled for February 5, 2014 was taken off of the calendar and rescheduled on March 4 and 5, 2014, and establishing pretrial/discovery deadlines.

On February 18, 2014 Respondent CAROLEE KUBO, Director, Department of Human Resources, City and County of Honolulu, by and through her counsel, filed a MOTION TO CONTINUE HEARING (Motion) scheduled for March 4 and March 5, 2014 in the above-captioned matter. Respondent's counsel stated in a Declaration dated February 18, 2014 that "[t]he parties are attempting to resolve the above-captioned matter and the underlying grievance in good faith." In the February 18, 2014 Declaration, Respondent's counsel further stated that "[o]n February 14, 2014, I spoke with Complainant's counsel, Herbert R. Takahashi, Esq., who does not object to continuing the above-captioned matter as well as suspending the deadlines as noted on this[sic] Board Order dated February 6, 2014."

The Board did not receive any opposition or objection to Respondent's Motion to Continue from Complainant UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (Complainant) in this matter.

Accordingly, for good cause shown, the Board hereby GRANTS Respondent's Motion to Continue, filed on February 18, 2014. Therefore, the following dates set by the Board's February 6, 2014 Notice of Hearing are continued: February 21, 2014 (deadline for issuance of subpoenas), February 25, 2014 (deadline for exchange witness lists and for exchange of exhibit lists), March 3, 2014 (submit copies of exhibits), and March 4 and 5, 2014 (trial dates).

NOTICE IS HEREBY GIVEN that the Board will hold a status conference in this matter on Friday, **April 4, 2014 at 9:00 a.m.** in the Board's hearing room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii.
