On August 5, 2014, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (Complainant), by and through its attorney, filed Complainant's Motion for Further Continuance of Pre-Hearing/Settlement Conference (Motion) with the Declaration of Debra A. Kagawa (Declaration). The Motion included a request to continue the prehearing/settlement conference (Conference) until such time that either party contacts the Board to schedule a

conference in this matter, if necessary. The Declaration stated that the reason for the request was based on information that a new hospital administrator was recently appointed and to allow more discussion of the Therapeutic Community Issue.

The Declaration also stated that Deputy Attorney General Richard Thomason has no objection to continuing the prehearing/settlement conference until either party contacts the Board to reschedule it, if necessary.

Based on the foregoing, the Board HEREBY:

- 1. GRANTS the motion to continue the Prehearing/Settlement Conference scheduled for August 18, 2014 at 9:00 a.m., and accordingly cancels the August 18, 2014 conference; and
- 2. DENIES the request to continue scheduling the conference until such time as either party requests a rescheduled conference, and accordingly continues the conference to the date and time below.

NOTICE IS HEREBY GIVEN that the Board will conduct a Continued Pre-Hearing Settlement Conference on October 21, 2014 at 9:00 a.m. in the Board's hearing room, 830 Punchbowl Street, Room 434, Honolulu, Hawaii.
