## ORDER GRANTING MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON APRIL 15, 2014

On March 6, 2015, the HAWAII FIRE FIGHTERS ASSOCIATION (HFFA, Complainant) by and through its attorneys Peter Liholiho Trask, Esq., filed a MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON OCTOBER 28, 2013, (Motion) with the Hawaii Labor Relations Board (Board), pursuant to Hawaii Administrative Rules (HAR) §12-42-8 (3) (c). However, there is no HAR Rule §12-42-8(3)(c). The Board finds that the Motion and the Declaration of Peter Liholiho Trask, Esq. clearly demonstrates that HFFA/IAFF wishes to withdraw the above-stated complaint.

Contrades filed RESPONDENT'S STATEMENT OF NO OPPOSITION TO COMPLAINANT'S MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT FILED ON OCTOBER 28, 2013.

HAR § 12-42-44 provides that "Any complaint may be withdrawn at any time prior to the issuance of a final decision and order thereon, upon motion and consent of the board. Whenever the board approves withdrawal of such complaint, the case shall be closed." Based on a review of the record and consideration of the instant motion and the response thereto, the Board consents and grants the withdrawal of the instant Complaint, with prejudice. This case is closed.
