ORDER APPOINTING ARBITRATION PANEL AND NEUTRAL ARBITRATOR AND CHAIRPERSON

ORDER APPOINTING ARBITRATION PANEL AND NEUTRAL ARBITRATOR AND CHAIRPERSON

By letter dated June 5, 2015, James K. Nishimoto, Chief Negotiator State of Hawaii informed the Hawaii Labor Relations Board (Board) that the parties in this matter selected C. Allen Pool as the neutral arbitrator in the bargaining unit (BU) 08 interest arbitration by utilizing the strike method.

Hawaii Revised Statutes (HRS) § 89-11(e)(2)(A) provides in relevant part, "the parties shall alternately strike names from the list until a single name is left, who shall be immediately appointed by the board as the neutral arbitrator and chairperson of the arbitration panel" (emphasis added). Accordingly, pursuant to HRS § 89-11(e)(2)(A), the Board hereby appoints C. Allen Pool as the neutral arbitrator and chairperson of the BU 08 interest arbitration panel. Additionally, based upon correspondence from the parties indicating their selections of party representatives to the panel, the remaining panel members are Dr. J. N. Musto, selected by HGEA, the exclusive representative and Donna Kiyosaki, selected by the Employers. The panel shall have the powers conferred by law and shall follow the arbitration procedures provided for in HRS § 89-11 or an alternate impasse procedure as provided by HRS § 89-11(a).
