On June 15, 2015, the Hawaii State Teachers Association (Petitioner, HSTA) filed HAWAII STATE TEACHERS ASSOCIATION'S MEMORANDUM OF FACT AND LAW in the above-entitled case.

On June 16, 2015, HSTA by and through its attorney Rebecca L. Covert, Esq., filed HSTA'S MOTION FOR THE BOARD TO ACCEPT HAWAII STATE TEACHERS ASSOCIATION'S AMENDED MEMORANDUM OF FACT AND LAW FILED JUNE 16, 2015 (Motion) in accordance with Hawaii Administrative Rules (HAR) § 12-42-8(g)(10)(A) with the Hawaii Labor Relations Board (Board).

In Ms. Covert's declaration, she stated that she had consulted with Deputy Attorney General Richard Thomason, the attorney for Intervenor KATHRYN MATAYOSHI, Superintendent, Department of Education, State of Hawaii (Intervenor), who indicated that he had no objections to the Board's receipt of HSTA's amended post hearing brief.

Pursuant to HAR § 12-42-8(g)(3)(iii), the Intervenor had five days after service of the Motion to file an opposition. Board records indicate that the Intervenor did not file an opposition to the Motion.

ACCORDINGLY, based on the record and for good cause, the Board hereby grants the Motion and accepts the June 16, 2015 Amended Memorandum of Facts and Law.¹
