On July 17, 2015, Complainant KENNETH M. FARIA, JR. (Complainant) filed with the Hawaii Labor Relations Board (Board) a letter requesting a two month extension to seek a lawyer (Request). On July 20, 2015, Respondent UPW, by and through their attorney, filed "Union Respondent's Objections to Complainant's Request for Two Months Extension of Time dated July 17, 2015. No other objection to Complainant's Request was received by the Board.

Complainant is a *pro se* or a self-represented individual, who is not familiar with the Hawaii Revised Statutes, Chapter 89 or the Hawaii Administrative Rules (HAR) Chapter 12, Title 12. Therefore, the Board will treat Complainant's Request as a motion pursuant to 12-42-8(g)(3). Complainant requested a two month extension. The Board interprets Complainant's request to mean a two month extension from the deadline for Complainant's response to Union's Motion to Dismiss filed on July 2, 2015 and the motion hearing scheduled for July 30, 2015 at 1:00 p.m. Accordingly, for good cause shown, the Board hereby GRANTS Complainant's request for a two month extension.

NOTICE IS HEREBY GIVEN that the motion hearing on Union's Motion to Dismiss scheduled for 1:00 p.m. on July 30, 2015 is hereby taken off of the calendar.

NOTICE OF CONTINUED MOTION HEARING AND DEADLINES

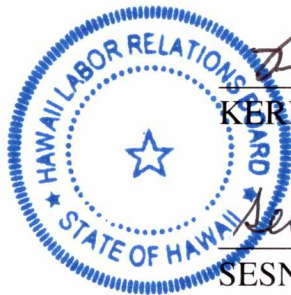
