Upon due consideration of Respondent BOARD OF REGENTS, University of Hawaii's Motion to Extend Time to Answer or Otherwise Respond to Complaint filed on August 18, 2015, (Motion), and finding good cause therefore,

IT IS HEREBY ORDERED that Respondent's Motion requesting to extend time to answer or otherwise respond to Complaint filed on August 18, 2015 is GRANTED, and the new deadline is September 28, 2015.

IT IS FURTHER ORDERED that the scheduled dates for the Prehearing/Settlement Conference and hearing on the merits of the prohibited practice complaint as set forth in the Board's Notice to Respondents of Prohibited Practice

Complaint; Notice of Prehearing/Settlement Conference and Notice of Hearing on the Prohibited Practice Complaint dated August 19, 2015 are extended by one month. As such, the Board hereby gives notice that (i) the Prehearing/Settlement Conference which was previously scheduled for September 8, 2015 at 9:30 a.m. is rescheduled for October 8, 2015 at 10:00 a.m., and (ii) the hearing on the merits of the instant complaint which was previously scheduled for September 23, 2015 at 1:00 p.m. is rescheduled for October 23, 2015 at 9:00 a.m.

IT IS FURTHER ORDERED that, pursuant to the agreement of the parties, the deadlines set forth in § 377-9(b), Hawaii Revised Statutes and § 12-42-46(b), Sub-Chapter 3, Chapter 42, Title 12, Hawaii Administrative Rules are also extended by one month.
