Pursuant to the notice of the Hawaii Labor Relations Board (Board) filed on September 9, 2015, a Prehearing/Settlement Conference was scheduled to be held among the parties on October 2, 2015, at 9:30 a.m. in the Board's Hearing Room, Room 434, 830 Punchbowl Street, Honolulu, Hawaii. Also, in that same notice a hearing on the merits of the instant complaint was set for October 8, 2015 at 1:00 p.m.

On September 17, 2015, Respondents, through their attorney, Debra A. Kagawa, Esq., filed Respondents Hawaii Government Employees Association, AFSCME, Local 152, AFL-CIO, Stanford Chun and Joan Takano's Motion to Continue Prehearing/Settlement Conference and Hearing on the Merits ("Motion to Continue"). Respondents filed an Erata to the Motion to Continue on September 21, 2015. In the Motion to Continue, Respondents seek a continuance of the Prehearing/Settlement Conference from October 2, 2015 to October 8, 2015 at 1:00 p.m. and that the hearing on the merit would be rescheduled to a date and time set by the Board at Prehearing/Settlement Conference. Complainant has not objected to the Motion to Continue or the requested continuance made by Respondents.
