ORDER GRANTING COMPLAINANT STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS' (SHOPO) MOTION TO WITHDRAW PROHIBITED PRACTICE COMPLAINT

On May 22, 2015, Complainant STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS (SHOPO) filed a prohibited practice complaint (Case No. CE-12-861) with the Hawaii Labor Relations Board (Board) against Respondents KIRK CALDWELL, Mayor of the City and County of Honolulu, State of Hawaii, LOUIS M. KEALOHA, Chief of Police, Honolulu Police Department, and the CITY AND COUNTY OF HONOLULU, a political subdivision of the State of Hawaii (collectively Respondents).

On October 29, 2015, SHOPO filed Complainant State of Hawaii Organization of Police Officers' (SHOPO) Motion to Withdraw Prohibited Practice Complaint (Motion to Withdraw PPC), citing Section 12-42-44 of the Board's rules. The Motion to Withdraw PPC was accompanied with the Affidavit of Norman K. Kato II, Esq., the attorney for SHOPO (Kato's

on October 13, 2015 that SHOPO would be withdrawing the complaint in CE-12-861.

Section 12-42-44 of the Board's Rules states in part:

Section 12-42-44 Withdrawal. Any complaint may be withdrawn at any time prior to the issuance of a final order thereon, upon motion and with the consent of the board. Whenever the board approves withdrawal of such complaint, the case shall be closed.

With the filing of the Motion to Withdraw PPC, SHOPO has met the first two of the three requirements of Section 12-42-44, and the sole issue before this Board is whether to consent to or reject SHOPO's request to withdraw the prohibited practice complaint.

There being no reason to deny SHOPO's withdrawal request, the Board hereby approves the withdrawal of the complaint filed in CE-12-861. This case is closed.
