ORDER (A) GRANTING (1) RESPONDENT DAYTON NAKANELUA, STATE DIRECTOR, UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO'S MOTION TO APPROVE WITHDRAWAL OF COMPLAINT (FILED 1/14/2016), (2) COMPLAINANT DAVID J.K.K. CRIVELLO'S MOTION FOR LEAVE TO WITHDRAW COMPLAINT AND AMENDED COMPLAINT (FILED 1/15/2016) AND (3) RESPONDENT KYLE GINOZA, DIRECTOR, DEPARTMENT OF **ENVIRONMENTAL** MANAGEMENT, COUNTY OF MAUI'S MOTION TO APPROVE WITHDRAWAL OF COMPLAINT AND AMENDED COMPLAINT (FILED 1/15/2016) AND (B) **CLOSING CASE** 

ORDER (A) GRANTING (1) RESPONDENT DAYTON NAKANELUA, STATE DIRECTOR, UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO'S MOTION TO APPROVE WITHDRAWAL OF COMPLAINT (FILED 1/14/2016), (2) COMPLAINANT DAVID J.K.K. CRIVELLO'S MOTION FOR LEAVE TO WITHDRAW COMPLAINT AND AMENDED COMPLAINT (FILED 1/15/2016) AND (3) RESPONDENT KYLE GINOZA, DIRECTOR, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, COUNTY OF MAUI'S MOTION TO APPROVE WITHDRAWAL OF COMPLAINT AND AMENDED COMPLAINT (FILED 1/15/2016) AND (B) CLOSING CASE

Respondent Dayton Nakanelua, State Director, United Public Workers, AFSCME, Local 646, AFL-CIO (Union) filed a Motion to Approval Withdrawal of Complaint with the

Hawaii Labor Relations Board on January 14, 2016 (Union Motion), Complainant David J.K.K. Crivello (Complainant) filed a Motion for Leave to Withdraw Complaint and Amended Complaint on January 15, 2016 (Crivello Motion) and Respondent Kyle Ginoza, Director, Department of Environmental Management, County of Maui (County) filed a Motion to Approve Withdrawal of Complaint and Amended Complaint on January 15, 2016 (County Motion).

Each of the parties represented to the Board that the above-entitled action was settled, and that Complainant agreed to withdraw the Prohibited Practice Complaint filed on November 19, 2015 against both the County and Union. In addition, the Complainant and County requested that the Board approve the withdrawal of an Amended Prohibited Practice Complaint filed on December 14, 2016. As such, the Board shall treat the Union Motion, Complainant's Motion and the County Motion as a joint (1) notification to the Board that Complainant is withdrawing the Prohibited Practice Complaint filed on November 19, 2015 and the Amended Prohibited Practice Complaint filed on December 14, 2015 and (2) request that the Board grant the motions without a hearing, approve and accept the withdrawal of said complaints and close Case Nos. CE-01-871 and CU-01-339.

Based on the foregoing, and in accordance with Hawaii Administrative Rules Sections 12-42-8(g)(3)(C) and 12-42-44, the Board unanimously:

The Amended Prohibited Practice Complaint is currently the subject of a Motion to Strike Complainant's Amended Prohibited Practice Complaint Filed on December 14, 2015 filed on December 16, 2015 by the Union, and a Motion for Leave to File Amended Complaint filed on January 13, 2016. The Board did not rule on either motion. However, to avoid confusion (since the Amended Prohibited Practice Complaint was filed without the consent of the Board as required by Hawaii Administrative Rules Section 12-42-43 and is still part of the recorded in these cases), the Board will allow Complainant to withdraw the Amended Complaint without ruling on either motion.

- (1)Grants the Union and Complainant Motions;
- (2)Approves of, and accepts, the withdrawal of the Prohibited Practice Complaint filed on November 19, 2015 and the Amended Prohibited Practice Complaint filed on December 14, 2015, by the Complainant against the County and the Union; and
- Based on the foregoing, hereby closes both Case No. CE-01-871 and Case No. (3) CU-01-330.
