On February 1, 2016, the Hawaii Labor Relations Board (Board) issued Order No. 3143, "Order Granting Leave to File a Motion to Amend Prohibited Practice Complaint" in this matter.

On February 2, 2016, Complainant NATHAN MAKINO (Complainant) filed Complainant's Motion to Amend Complainant's Prohibited Practice Complaint filed on April 20, 2015 (Motion to Amend Complaint) by including and incorporating applicable BU 01 Collective Bargaining Agreement sections and clarifying the issues.

The Board did not receive any response to Complainant's Motion to Amend Complaint from the other parties.

HAR § 12-42-43 provides that "Any complaint may be amended in the discretion of the Board at any time prior to issuance of a final order." Accordingly, based on the Motion to Amend Complaint and review of the record herein, the Board in its discretion hereby grants Complainant's Motion to Amend Complaint pursuant to HAR § 12-42-43.

Complainant shall immediately file its Amended Prohibited Practice Complaint with the Board (Amended Complaint) attached to its Motion to Amend Complaint. Upon receipt of the Amended complaint the Board will issue a Notice to Respondents COUNTY OF HAWAII and UNITED PUBLIC WORKERS, AFSCME,

LOCAL 646, AFL-CIO (Respondents) of the Amended Complaint (Notice). Respondents shall have ten days after service of this Notice to file an answer to the Amended Complaint.
