On April 18, 2016, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (Complainant) filed a Motion to Continue Hearing (Motion to Continue) pursuant to Hawaii Administrative Rules (HAR) Section 12-42-8(g)(3)(C). In his declaration attached to the Motion to Continue, Peter Liholiho Trask, Complainant's attorney, represented that he and James E. Halvorson, attorney for Respondents DAVID Y. IGE, LANCE A. MIZUMOTO, the HAWAII STATE BOARD OF EDUCATION, KATHRYN S. MATAYOSHI and the DEPARTMENT OF EDUCATION (collectively, Respondents) "confirmed that [their] respective clients were talking and discussing the current

dispute, and reached an agreement to request the [Hawaii Labor Relations Board] to continue the hearing in this matter currently scheduled for Monday, April 25, 2016, to another date mutually convenient to the parties and the Board, not less than two (2) months from April 25, 2016."

Based on the foregoing representations, the Hawaii Labor Relations Board (Board) hereby:


