COMPLAINT (DEEMED FILED AS OF 04/27/2016)

On April 19, 2016, the Hawaii Labor Relations Board (Board) issued its Notice to Respondent(s) of Prohibited Practice Complaint; Notice of Prehearing Conference and Notice of Hearing on the Prohibited Practice Complaint (Notice). The Notice set certain prehearing deadlines and scheduled the hearing on the merits on the claims brought in the Prohibited Practice Complaint filed on April 18, 2016 (Complaint) by Complainant University of Hawaii Professional Assembly (Complainant) against Respondent Board of Regents, University of Hawaii (Respondent).

On April 26, 2016, Respondent submitted to the Board its Motion for Extension on Answer to Prohibited Practice complaint, Prehearing Statements, Prehearing Conference, and Hearing on Complaint (Motion for Extension). Since the Motion for Extension was submitted to the Board electronically at a time when the Board's office was not open, the Motion for Extension is deemed to be filed as of 7:45 a.m. on April 27, 2016. Respondent's counsel, in her declaration in support of the Motion for Extension, represented that Complainant's counsel agreed to an extension of time and the dates proposed by Respondent, including the setting of the hearing on the merits on June 13, 2016 or such other date as may be convenient to the Board.

Based on the foregoing and the agreement of the parties to waive the requirement that the Board hold the hearing on the merits not more than forty (40) days after the filing of the Complaint, the Board hereby grants the Motion for Extension and the following deadlines are established pursuant to the parties' agreement:

Answer to the Complaint	May 16, 2016
Prehearing Statements	May 24, 2016
Prehearing Conference	May 26, 2016 at 9:00 a.m.
Hearing on the Merits	July 5, 2016 at 9:00 a.m.

In light of the anticipated change in the Board's membership on July 1, 2016, the Board is reluctant to reschedule the Hearing on the Merits to a date prior to July 1. Thus, the Hearing on the Merits, and the pre-hearing deadlines have been rescheduled in accordance with this concern.


In all other respects, the Notice shall remain in full force and effect.
