On April 27, 2016, Complainant Hawaii Government Employees Association, AFSCME, Local 152, AFL-CIO (Complainant) and Respondents David Y. Ige, Suzanne Case, Jason Redulla, Shauna Tsuha and Alice Schutte (collectively, Respondents) filed their Stipulation to Dismiss Prohibited Practice Complaint (Stipulation). In the Stipulation, Complainant and Respondents, "by and through their respective counsel [stipulated and agreed]

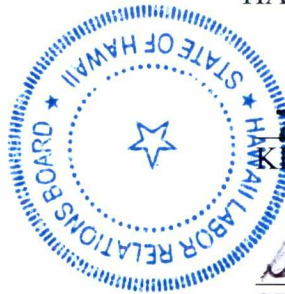
that the Prohibited Practice Complaint filed on January 28, 2016, is hereby dismissed with prejudice."
