**ORDER GRANTING INTERVENOR HFFA/IAFF'S
MOTION TO CONTINUE HEARING OF JANUARY 25, 2017**

On November 8, 2016, the HAWAII FIRE FIGHTERS ASSOCIATION, IAFF, LOCAL 1463, AFL-CIO, (Intervenor HFFA), filed with Hawaii Labor Relations Board (Board) a motion to continue the hearing in the above referenced case from January 25, 2017, as set forth in Board Order No. 3194.

On November 15, 2016, DAVID Y. IGE, Governor, State of Hawaii; ALAN ARAKAWA, Mayor, County of Maui; BERNARD CARVALHO, JR, Mayor, County of Kauai; BILLY KENOI, Mayor, County of Hawaii; and KIRK CALDWELL, Mayor, City and County of Honolulu (Petitioners) filed a Memorandum in Opposition to Intervenor HFFA/IAFF's Motion

to Continue the Hearing of January 25, 2017. However, in the Petitioners' Memorandum of Opposition they state, *inter alia*, "Public Employer objects to the continuing of the hearing on its DR Petition but will not object to the DR Petition hearing being held *prior* to its January 25, 2017 date.

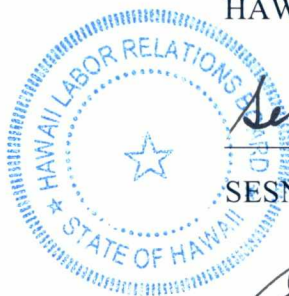
On November 16, 2016, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (Intervenor HGEA), filed Intervenor HGEA's Statement of No Opposition to Intervenor HFFA/IAFF's Motion to Continue Hearing of January 25, 2017, filed November 8, 2016.

Based on the Intervenor HFFA/IAFF's Motion, the Petitioners' response thereto, and the lack of opposition to the Motion by Intervenor HGEA,

IT IS HEREBY ORDERED that the Board will hear oral arguments in the above referenced Petition for a Declaratory Ruling on **Wednesday, January 18, 2017 at 9:00 am** in the Board's Hearing Room 434, 830 Punchbowl Street, Honolulu, Hawaii.
