STIPULATION AND ORDER TO RESCHEDULE DEADLINES RELATED TO HLRB'S PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW, AND DECISION AND ORDER

COMES NOW the HAWAII STATE TEACHERS ASSOCIATION (HSTA or Association) and KATHRYN MATAYOSHI, Superintendent, Department of Education, and the State of Hawaii, Intervenor by and through their undersigned counsel and hereby stipulate related to the deadlines set by the Hawaii Labor Relations Board (HLRB or Board) as to the Proposed Findings of Fact, Conclusions of Law, and Decision and Order in the above-entitled matter filed February 28, 2017:

WHEREAS, the Hawaii Labor Relations Board (HLRB) filed the Proposed Findings of Fact, Conclusions of Law, and Decision and Order in the above-entitled matter on February 28, 2017 with exceptions if any to be filed within ten days of the filing and a hearing on any exceptions filed to be heard on March 23, 2017; and

WHEREAS, counsel for HSTA has four appellate and circuit court briefs due in the next two weeks and oral argument before the Supreme Court at the end of the month for which preparation time is needed in addition to other scheduled deadlines in the next two weeks; and

WHEREAS, counsel for the Intervenor, the Department of Education, the State of Hawaii is out of state from March 3-10 and only returning to the office on March 13, 2013; and

WHEREAS, both counsel are scheduled for a working mediation session in another labor matter on March 23, 2017 before arbitrator/mediator Walter Ikeda.

NOW therefore, it is hereby stipulated and agreed to between the parties that

- 1. The deadlines for the filing of the exceptions is continued to <u>April 10, 2017</u>.
- 2. The Board will set a new date for a hearing for presentation of oral arguments on any exceptions sometime after April 10, 2017.
