ORDER AMENDING CASE NUMBER; APPROVING STIPULATION TO CONTINUE HEARING ON PROHIBITED PRACTICE COMPLAINT FILED ON MARCH 24, 2017; AND NOTICING CONTINUED HEARING AND DEADLINES

ORDER AMENDING CASE NUMBER; APPROVING STIPULATION TO CONTINUE HEARING ON PROHIBITED PRACTICE COMPLAINT FILED ON MARCH 24, 2017; AND NOTICING CONTINUED HEARING AND DEADLINES

As a preliminary matter, the Board notes that the Prohibited Practice Complaint filed on March 24, 2017, indicated that the appropriate bargaining unit in this matter is "Unit 10." However, at the prehearing conference held on April 11, 2017, Complainant confirmed that the correct bargaining unit is Unit 01. Accordingly, in keeping with the Board's convention for case numbering, the Board hereby amends the case number in this matter to **17-CE-01-892**. The parties should use this amended case number going forwarded, and a party using the File & ServExpress electronic filing system should note that the case documents will be found under the amended case number.

On April 17, 2017, the parties filed a Stipulation to Continue Hearing on Prohibited Practice Complaint Filed on March 24, 2017, and requested a rescheduled hearing date to "on or around July 10, 2017[.]" However, the Board is not available on July 10, 2017, and it is the Board's information and belief that the parties are available on July 18, 2017. Therefore, the Board hereby continues the hearing on the merits and oral arguments on dispositive motions, if any, to **Tuesday**,

July 18, 2017, at 9:00 a.m., to be held in the Board's hearing room located at 830 Punchbowl Street, Room 434, Honolulu, Hawaii, 96813.

Because of the rescheduled hearing date, the Board also hereby continues the following deadlines associated with the hearing that were listed in "PART IV - SCHEDULE OF DEADLINES AND HEARING DATES" contained in the Board's NOTICE OF HEARING ON THE MERITS OF THE PROHIBTIED PRACTICE COMPLAINT issued on March 29, 2017 (Notice of Hearing Issued March 29, 2017):

Dispositive motions are now due by June 21, 2017.

Responses to dispositive motions are due by **July 7, 2017**.

Applications for subpoenas are due by **June 28, 2017.**

The exchange of witness lists is due by **July 7, 2017**.

The exchange of exhibit lists is due by **July 7, 2017**.

The exchange and filing of proposed exhibits is due by **July 7, 2017**.

All other provisions in the Notice of Hearing Issued March 29, 2017, remain in effect. In the future, should the parties desire further continuance of the hearing and associated deadlines, the parties should file a motion to that effect with the Board.
