**SECOND STIPULATION AND ORDER TO RESCHEDULE DEADLINES

COMES NOW the Complainant United Public Workers, AFSCME, Local 646, AFL-CIO (UPW or Union) and the Respondents Patricia Hamamoto, Superintendent, Department of Education, State of Hawaii and Connections, A New Century Public Charter School, by and through their undersigned counsel and hereby stipulate related to the deadlines set by the Hawaii Labor Relations Board (HLRB or Board) as to the Proposed Findings of Fact, Conclusions of Law, and

Decision and Order in the above-entitled matter filed March 31, 2017 and as further amended by the Stipulation And Order To Reschedule Deadlines Related To HLRB's Proposed Findings Of Fact, Conclusions Of Law, And Decision And Order, filed April 5, 2017:

WHEREAS, the Hawaii Labor Relations Board (HLRB) filed the Proposed Findings of Fact, Conclusions of Law, and Decision and Order in the above-entitled matter on March 31, 2017 with exceptions if any to be filed within ten days of the filing; and

WHEREAS, the Hawaii Labor Relations Board (HLRB) filed the Stipulation And Order To Reschedule Deadlines Related To HLRB's Proposed Findings Of Fact, Conclusions Of Law, And Decision And Order on April 5, 2017 that set the deadline to file exceptions for May 15, 2017; and


WHEREAS, complainant seeks to file exceptions but counsel for complainant has had several matters including briefs and hearings over the past four weeks and into the next few weeks; and

WHEREAS, counsel for respondents has no objections to the complainant's request to a continuance on the deadline to file exceptions.


NOW therefore, it is hereby stipulated and agreed to between the parties that

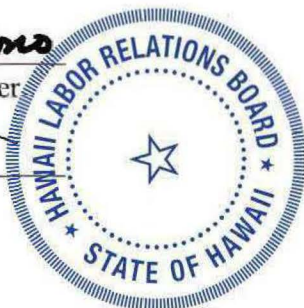
