On April 18, 2017, the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME LOCAL 152, AFL-CIO (Petitioner) with the Hawaii Labor Relations Board (Board) PETITION FOR CLARIFICATION OR AMENDMENT OF APPROPRIATE BARGAINING UNIT.

On April 25, 2017, the Board sent out NOTICE OF RECEIPT OF PETITION FOR CLARIFICATION OR AMENDMENT OF APPROPRIATE BARGAINING UNIT; NOTICE OF DEALINE FOR FILING PETITIONS FOR INTERVENTION; NOTICE OF BOARD CONFERENCE to the State of Hawaii, the City & County of Honolulu, the County of Hawaii, the County of Maui, and the County of Kauai.

On May 1, 2017, the CITY & COUNTY OF HONOLULU, Department of Human Resources, filed with the Board a Petition for Intervention in the entitled cases.

On May 15, 2017, the Board held an initial conference pursuant to the Board's Notice. Present at the conference were Debra A. Kagawa, Esq., representing the Petitioner, and Paul K. Hoshino, Esq., representing the City & County of Honolulu. The

Board then considered the Petition for Intervention brought by the City & County of Honolulu. The Petitioner had no objection to the Petition for Intervention.

Accordingly, based on the above and for good cause shown, the Board **HEREBY GRANTS** CITY AND COUNTY OF HONOLULU, DEPARTMENT OF HUMAN RESOURCES PETITION FOR INTERVENTION.

1. Application for the issuance of subpoenas of Petitioner's first 5 witnesses. If subpoenas are issued, the Board requests that parties send a courtesy copy to all opposing parties and file the proof of service with the Board by the next business day following service.

2. Exchange of Witness List: The witness list shall include, in the interest of judicial economy, a brief but meaningful summary or general statement of the nature of the testimony expected, and the order in which the witnesses are expected to be called. The summary or general statement for each witness shall include sufficient information for the Board to determine whether the testimony will be irrelevant, immaterial, or unduly repetitious to any other witness testimony; see, Hawaii Revised Statutes § 91-10(1) and Hawaii Administrative Rules § 12-42-8(g)(8)(B).

**3. Exchange of Exhibit Lists:** Petitioner's exhibits shall be marked using numbers (e.g., 1, 2, 3, etc.) and Intervenor City and County of Honolulu's exhibits shall be marked using letters of the alphabet (e.g. A-B-C-, etc.).

4. Copies of exhibits shall be provided to the Board as follows:
