**ORDER GRANTING THE UPW’S MOTION TO EXTEND  
THE DEADLINE FOR FILING OF POST HEARING BRIEFS  
UNTIL AFTER A RULING ON RESPONDENT’S MAY 24, 2017 MOTION**

On June 6, 2017, Respondent UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO (Respondent or UPW) filed a MOTION TO EXTEND THE DEADLINE FOR FILING OF POST HEARING BRIEFS UNTIL AFTER A RULING ON RESPONDENT’S MAY 24, 2017 MOTION (Motion to Extend Deadline for Filing of Briefs). Respondent’s “May 24, 2017 Motion” is a motion for a ruling from the Hawaii Labor Relations Board (Board) to grant Respondent’s October 24, 2016, motion to dismiss the prohibited practice complaint (Motion to Dismiss Complaint).

Pursuant to Hawaii Administrative Rules (HAR) § 12-42-8(g)(3)(C)(iii), an opposition to a motion other than one made at hearing, must be filed within five days. Here, Complainants have not filed an opposition to the UPW’s Motion to Extend Deadline for Filing of Briefs.

For good cause shown by the UPW, the Board hereby GRANTS the Motion to Extend Deadline for Filing of Briefs. After the Board issues a ruling on the Motion to Dismiss Complaint, the Board will set a deadline for the filing of post-hearing briefs, if necessary.
