WHEREAS, counsel for HLRB, Sarah Hirakami, advised the Board is amenable to continuing the deadline;

NOW therefore, it is hereby stipulated and agreed to between all parties if so ordered by the Board that the deadline to submit the Proposed Findings of Facts, Conclusions of Law, and Proposed Order and Decision in the above-entitled matter be rescheduled from Monday, September 1, 2017 to **Monday, September 18, 2017**.
