Rebecca L. Covert, Esq., and Jeffrey A. Keating, Deputy Attorney General, hereby submit a Second Stipulation And Order On Filing Proposed Findings Of Fact And Proposed Order And Decision related to the deadline set by the Hawaii Labor Relations Board (HLRB or Board) by Order 3245 filed on April 11, 2017 for the parties to submit to the Board a statement of Proposed Findings of Facts, Conclusions of Law, and Proposed Order and Decision.

WHEREAS, the deadline set by HLRB in its Order 3245 for the parties to submit to the Board a statement of Proposed Findings of Facts, Conclusions of Law, and Proposed Order and Decision was by stipulation set for Monday, September 18, 2017; and

WHEREAS, counsel for UPW had several deadlines recently come in, including filings at the Supreme Court, Intermediate Court of Appeals (ICA), and Circuit Court, due on or before September 15, 2017 and then several other deadlines in the following weeks; and

WHEREAS, counsel for HLRB, Sarah Hirakami, advised the Board is amenable to continuing the deadline;

NOW therefore, it is hereby stipulated and agreed to between all parties if so ordered by the Board that the deadline to submit the Proposed Findings of Facts, Conclusions of Law, and Proposed Order and Decision in the above-entitled matter be rescheduled from Monday, September 18, 2017 to **Monday, October 16, 2017**.

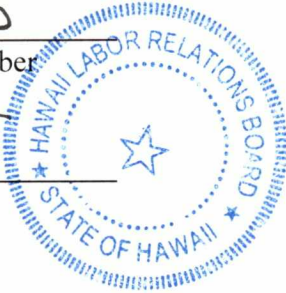
