1. 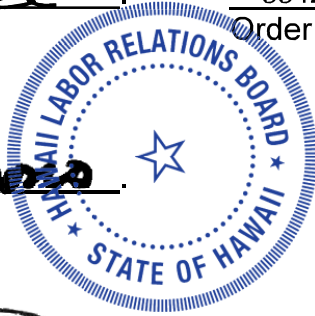
