CONTINUE HEARING ON THE MERITS ON APRIL 25, 2018


On April 11, 2018, the UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (Complainant, UHPA), filed Complainant UHPA's Motion to Continue Hearing on the Merits on April 25, 2018. with the HAWAII LABOR RELATIONS BOARD (Board) in accordance with Hawai'i Administrative Rules § 12-42-8 and made pursuant to Rules 7, 12 and 81 of the Hawai'i Rules of Civil Procedure, and the Declaration of David A. Sgan in support of the motion.

On April 13, 2018, DAVID LASSNER, President, University of Hawai'i and Interim Chancellor, University of Hawai'i at Manoa, and BOARD OF REGENTS, University of Hawai'i, (collectively Respondents), by and through their attorney, filed Respondents David Lassner and Board of Regents' position regarding UHPA's Motion to Continue Hearing on the Merits on April 25, 2018, filed April 11, 2018, stating, "Respondents are agreeable to continuing the hearing on the merits and all related deadlines and to waiving the 40-day rule for the sole purpose of accommodating witness availability and not for any other purpose, including engaging in extensive discovery."

Based upon Complainant's Motion and Respondents' response thereto, the Board grants the Complainant's Motion to Continue the Hearing on Merits, removing it from the calendar along with all the related deadlines as set forth in (6) SCHEDULE OF HEARINGS, CONFERENCES AND DEADLINES of Board Order No. 3332. In all other respects, Order No. 3332 remains in effect. However, the Pretrial Conference scheduled for Thursday, April 19, 2018 will proceed as noticed by the Board on April 10, 2018, commencing at **8:00 a.m.**


