TEMPORARY RESTRAINING ORDER

TEMPORARY RESTRAINING ORDER

On May 23, 2018, Complainant STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS (SHOPO) filed Complainant SHOPO's Motion for Emergency Temporary Interlocutory Order to Enjoin Respondent's Release of Confidential Records and Information (Motion for Emergency Temporary Interlocutory Relief) with the Hawaii Labor Relations Board (Board) in the above-referenced case.

On May 23, 2018, the Board issued a Notice of Hearing on Complainant SHOPO's Motion for Emergency Relief notifying the Complainant and Respondents SUSAN BALLARD, Chief of Police, Honolulu Police Department (Chief Ballard), City and County of Honolulu; and CITY AND COUNTY OF HONOLULU (collectively Respondents) that the Board would hold a hearing on the Motion for Emergency Temporary Interlocutory Relief on Thursday, May 24, 2018 at 1:00 p.m. in the Board's hearing room at 830 Punchbowl Street, Room 434; Honolulu, Hawaii 96813.

Following the May 24, 2018 hearing, after reviewing the Motion for Emergency Temporary Interlocutory Relief and the arguments from Complainant and Respondents, the Board, among other things, finds that the release of information pertaining to public employees included in bargaining unit 12 referenced in the May 23, 2018 video sent to personnel in the Honolulu Police Department by Chief Ballard will cause immediate and irreparable harm to the

individual privacy of those individuals whose information was referenced, and issues the following order:

Respondents SUSAN BALLARD, Chief of Police, Honolulu Police Department, City and County of Honolulu; and CITY AND COUNTY OF HONOLULU, their officers, agents, servants, employees, and attorneys, and those in active concert or participation with them who receive actual notice of the order by personal service or otherwise are restrained from releasing the written decision of the Arbitrator and any other information referred to in a May 23, 2018 video message sent to personnel in the Honolulu Police Department by Chief Ballard.

This temporary restraining order shall remain in effect until a second hearing on the Motion for Temporary Interlocutory Relief is held on Monday, June 4, 2018 at 1:00 p.m.
