On July 27, 2018, David A. Sgan, attorney for the UNIVERSITY OF HAWAII PROFESSIONAL ASSEMBLY (Complainant, Union), filed a letter, with the HAWAII LABOR RELATIONS BOARD (Board) which was co-signed by Elisabeth Contrades, attorney for DAVID LASSNER, President, University of Hawaii and Interim Chancellor, University of Hawaii at Manoa and BOARD OF REGENTS, University of Hawaii (Respondents, Employer) stating in part, "The union and the Employer have agreed to meet to settle this case [CE-07-913] and to; jointly request a continuance of the scheduled pretrial conference and evidentiary hearing dates." Pursuant to Hawai'i Administrative Rules (HAR) § 12-42-8(g)(3)(C)(i), the Board shall consider the written communication as a motion in the form of a stipulation agreed to by the parties.

Based upon the stipulation of the parties requesting a continuance of the pretrial conference and the hearing on the merits, the Board grants the continuance, removing from the calendar the PRETRIAL CONFERENCE scheduled for July 3, 2018, and the HEARING ON MERITS, scheduled for July 11, 12, 2018
