WHEREAS, Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO (“HGEA”), through its counsel and representative, and Respondents KIRK CALDWELL, Mayor, City and County of Honolulu; ERNEST Y.W. LAU, P.E., Manager and Chief Engineer of the Board of Water Supply; ELLEN KITAMURA, Deputy Manager and Chief Engineer of the Board of Water Supply; CAROLEE KUBO, Director, Department of Human Resources, City and County of Honolulu; and NOEL ONO, Assistant Director, Department of Human Resources, City and County of Honolulu (“City Respondents”), through their attorney, ERNEST H. NOMURA, Deputy Corporation Counsel, have been in good faith negotiating a settlement of the pending prohibited practice complaint in this matter;

WHEREAS, counsel for HGEA recently withdrew as counsel and substitute representative recently appeared in this case and requires time to review the case file and status of the settlement negotiations;

WHEREAS, settlement documents have been exchanged between the parties and are currently under review by HGEA;

WHEREAS, HGEA is in the process of contacting and working with its impacted members to consider the terms of the settlement and resolution of this case;

WHEREAS, the parties, by its counsel and representative, believe that a short continuation of the status conference in this matter is needed so that impacted HGEA members may be consulted regarding the terms of the settlement and that the parties should be able to close the settlement prior to any continued status conference before the Board and enter a stipulation to dismiss this case with prejudice as part of the settlement of the case;

THEREFORE, IT IS HEREBY STIPULATED between Complainant HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO, through its representative, and Respondents KIRK CALDWELL, Mayor, City and County of Honolulu; ERNEST Y.W. LAU, P.E., Manager and Chief Engineer of the Board of Water Supply; ELLEN KITAMURA, Deputy Manager and Chief Engineer of the Board of Water Supply; CAROLEE KUBO, Director, Department of Human Resources, City and County of Honolulu; and NOEL ONO, Assistant Director, Department of Human Resources, City and County of Honolulu, through their attorney, ERNEST H. NOMURA, Deputy Corporation Counsel, that the Status Conference, currently scheduled on October 25, 2018, at 9:00 a.m. shall be continued to ^{Ms} December 14, 2018, ~~December 15, 2018,~~ SM at 9:00 a.m., or as soon thereafter as the members of the Board may accommodate the parties, in the Board's hearing room, 830 Punchbowl Street, Room 434, Honolulu, Hawaii.

The parties understand and agree that if the case is resolved by way of settlement before the new status conference date, then a stipulation to dismiss all claims and all parties with prejudice shall be filed forthwith.

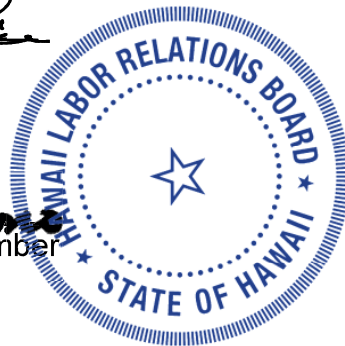
