**NOTICE OF WAIVER OF § 377-9(b), HAWAI'I REVISED STATUTES AND
§ 12-42-46(b), SUBCHAPTER 3, CHAPTER 42, TITLE 12, HAWAI'I
ADMINISTRATIVE RULES, ORDER CONSOLIDATING CASES AND
AMENDING PRETRIAL ORDER NOS. 3401-3408 AND NOTICE OF MOTION HEARING**

On November 5, 2018, the Hawaii Labor Relations Board (Board) held Prehearing Conferences in the above-referenced prohibited practice cases. The Complainants were all present in person or by phone conference and represented by Complainant JENNIFER E. HALASZYN. Translators were provided and present for Complainants IINUMA and YUAN. The Respondents

were present through representation by counsel. The parties agreed to waive the requirement of § 377-9(b), Hawaii Revised Statutes and § 12-42-46(b), Sub-Chapter 3, Chapter 42, Title 12, Hawaii Administrative Rules (HAR) that the hearing on the Complaint “be held no less than ten and nor more than forty days after the filing of the Complaint or amendment thereof”. All parties agreed to the following orders, deadlines, and hearing on the merits date.

The Board, on its own initiative, HEREBY ORDERS the consolidation of the above cases pursuant to HAR § 12-42-8(g)(13) which provides:

The board, on its own initiative or upon motion, may consolidate for hearing or other purposes or may contemporaneously consider two or more proceedings which involve substantially the same parties or issues if it finds that such consolidation of proceedings or contemporaneous consideration will be conducive to the proper dispatch of its business and to the ends of justice and will not unduly delay the proceedings.

The Board also ORDERS Pretrial Order Nos. 3401-3408 be amended as follows:

November 20, 2018 (close of business)

Deadline to file Exhibit and Witness Lists; Proposed Exhibits; and Application for Subpoenas.

November 27, 2018 at 9:00 a.m. – Hearing on the Merits.

All previous deadlines and hearings have been canceled and removed from the calendar. All other provisions not affected by this Order remain in effect.

ACCORDINGLY, NOTICE IS HEREBY GIVEN that the hearing on the merits of the consolidated cases scheduled for November 26, 2018 has been taken off the calendar and rescheduled to November 27, 29, and 30, 2018 at 9:00 a.m. and November 28, 2018 at 10:00 a.m. in the Board’s Hearing Room, Room 434, 830 Punchbowl Street, Honolulu, Hawai‘i.


