**STIPULATION WAIVING SECTION 377-9(b),
HRS & SECTION 12-42-46(b), HAR, and TO
CONTINUE HEARING SCHEDULED FOR NOVEMBER 23, 2018**

COMES NOW, JENNIFER E. HALASZYN, Complainant in the above-captioned matter, ("Complainant" herein), and the HAWAII GOVERNMENT EMPLOYEES ASSOCIATION, AFSCME, LOCAL 152, AFL-CIO, Respondent in the above-captioned matter ("HGEA/AFSCME" herein), by and through it attorney, PETER LIHOLIHO TRASK, ESQ., and hereby stipulate to the following:

1. The parties agree to waive the requirements of Section 377-9(b), Hawaii Revised Statutes (HRS), and Section 12-42-46(b), Sub-Chapter 3, Chapter 42, Title 12, Hawaii Administrative Rules (HAR) that the hearing on the Complainant "be held no less than ten and nor more than forty days after the filing of the Complainant or amendment thereof".

2. The Hearing on the merits of this case currently scheduled for November 23, 2018, at 9:00 a.m., be continued for 45 days for the parties to complete the necessary documentation to resolve this dispute.

3. A Status Conference shall be scheduled by the Board if need be with notice to the parties.
