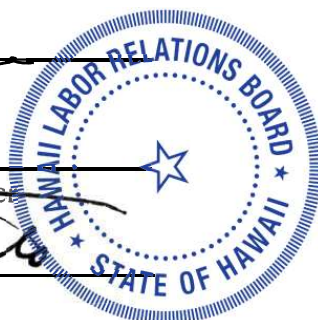

Pursuant to your instruction, we report to the Hawaii Labor Relations Board that Complainant and Respondent have reached an agreement to settle the complaint and to file a Stipulation and Order to Dismiss the Prohibited Practice Complaint Without Prejudice.
