ORDER GRANTING AMENDMENT OF PROHIBITED
PRACTICE CHARGE AND NOTICE TO RESPONDENT
OF AMENDED PROHIBITED PRACTICE COMPLAINT

YOU ARE HEREBY NOTIFIED THAT Joseph N. A. Ryan, Jr. filed with this Board an amended prohibited practice complaint, attached hereto, alleging that you have engaged in or are engaging in prohibited practices in violation of HRS §89-13.

YOU ARE ALSO NOTIFIED THAT the original prohibited practice complaint was filed by Joseph N. A. Ryan, Jr. on August 17, 1981 against the State of Hawaii Organization of Police Officers (hereafter SHOPO) in Case No. CU-12-40. That complaint was consolidated by the Board in Order No. 422 with prohibited complaints filed by Jerrold G. Brown and those similarly situated, Case No. CU-12-41, and Boisse P. Correa and those similarly situated, Case No. CU-12-42. By that Order the hearing on the complaints was scheduled on September 25, 1981 at 9:30 a.m. in the Board's hearings room, second floor, 550 Halekauwila Street, Honolulu, Hawaii. The hearing as originally scheduled is subject to continuance for good cause, upon the request of any party.

Pursuant to Board Rule §12-42-43, the Board in its discretion hereby grants Complainant Ryan's amendment to his Prohibited Practice Complaint filed on August 17, 1981.

YOU ARE DIRECTED to file with the Board the original and five (5) copies of your answer, with proof of service upon Complainant, no later than 4:30 p.m. of the tenth calendar day after receipt of the complaint. If you fail to timely file and serve an answer, such failure shall constitute an admission of the material facts alleged in

the complaint and a waiver of a hearing. However, if necessary, under Board Rule §12-42-45(b), a Motion for Particularization of the Complaint may be filed within five (5) days after service of the complaint. The filing of such a motion will extend the time for submission of an answer.
