## ORDER GRANTING MOTION TO SEVER CONSOLIDATED PROHIBITED PRACTICE COMPLAINTS

By Order No. 422, dated September 4, 1981, this
Board ordered the consolidation of Case Nos. CU-12-40,
CU-12-41 and CU-12-42 for disposition because the complaints apparently involved substantially the same parties and issues. On September 15, 1981, Complainant Joseph N. A.
Ryan, Jr., filed an Amended Prohibited Practice Complaint naming as Respondents, in addition to previously named
State of Hawaii Organization of Police Officers (hereafter SHOPO), George R. Ariyoshi, Governor of the State of Hawaii;
Eileen Anderson, Mayor of the City and County of Honolulu;
Herbert T. Matayoshi, Mayor of the County of Hawaii;
Hannibal Tavares, Mayor of the County of Maui; and Eduardo
E. Malapit, Mayor of the County of Kauai. Moreover, additional factual allegations were included in the Amended
Complaint.

At the continued prehearing conference held on September 23, 1981, counsel for Respondent Hannibal Tavares, Mayor of the County of Maui, orally moved to sever Case No. CU-12-40 from Case Nos. CU-12-41 and CU-12-42 due to the addition of Respondents and resulting procedural complexities.

Upon consideration of the arguments presented in support of said motion, the Board is of the opinion that the presence of additional Respondents and issues in Case No. CU-12-40, as amended, unduly complicates the resolution of the issues presented and further, that the consolidation of the cases will unduly delay the proceedings.

Hence, for good cause shown, the Board grants Maui County's motion to sever Case Nos. CU-12-40 and CE-12-74 from consolidated Case Nos. CU-12-41 and CU-12-42.
