ORDER GRANTING MOTION FOR PARTICULARIZATION

On October 28, 1981, Respondent, by his attorney, filed with this Board a Motion for Particularization of the Complaint herein, together with a supporting affidavit.

Upon review of the aforesaid motion and affidavit and the charges set forth in the complaint, the Board concludes that particularization of the complaint as requested in Respondent's motion should be granted.

Complainant's particularization should set forth: 1) the subsections of HRS §89-13 which Complainant alleges have been violated, and 2) state facts regarding what collective bargaining contract remedies have been pursued by Complainant.

The Board directs the above-named Complainant to file with this Board the original and five (5) copies of the requested particularization, with proof of service upon Respondent, no later that 4:30 p.m. of the fifth working day after the service of this order. If Complainant fails to timely file and serve the particularization, the Board shall dismiss the complaint.

The Respondent is directed to file with this Board the original and five copies of the answer, with proof of service upon Complainant, no later than 4:30 p.m. of the fifth working day after service of the Complainant's particularization. Failure of Respondent to timely file his answer shall constitute an admission of the material facts alleged in the complaint and particularization and a waiver of a hearing.
