ORDER GRANTING RESPONDENT'S MOTION FOR
EXTENSION OF TIME TO FILE EXCEPTIONS TO PROPOSED
FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

On October 6, 1982, a Hearings Officer for the Hawaii Public Employment Relations Board [hereinafter referred to as Board] issued Proposed Findings of Fact, Conclusions of Law and Order for the above-entitled case with the proviso that any party adversely affected could file exceptions with the Board within 10 days of service of a certified copy of the proposed decision.


On October 6, 1982, counsel for STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS [hereinafter referred to as

SHOPO] was served with a certified copy of the Proposed Findings of Fact, Conclusions of Law and Order. Thereafter, on October 14, 1982, SHOPO, by and through its counsel, filed a Motion for Extension of Time to File Respondent's Exceptions to Proposed Findings of Fact, Conclusions of Law and Order. By its motion, SHOPO requested an extension of time from October 18, 1982 until October 25, 1982. In a supporting affidavit, counsel stated he is currently conducting research with respect to the Exceptions to Proposed Findings and did not anticipate its completion before the October 18, 1982 deadline.

The Board hereby grants SHOPO's motion for extension of time from October 18, 1982 until October 25, 1982.
