## ORDER GRANTING PETITIONER HGEA'S MOTION TO WITHDRAW PETITION FOR DECLARATORY RULING

On July 7, 1981, the HAWAII GOVERNMENT EMPLOYEES' ASSOCIATION [hereinafter referred to as Petitioner or HGEA], by and through its attorney, filed a Petition for Declaratory Ruling with this Board. As the representative of employees in bargaining units 1, 2, 3, 4, 9, 10 and 13 at Hawaii State Hospital, Petitioner HGEA sought a determination of whether issues raised in a pending Circuit Court proceeding fell within the terms of the applicable collective bargaining agreement so as to be beyond the Court's jurisdiction. On August 3, 1981, the State of Hawaii filed a Petition for Intervention which was subsequently granted by Order No. 421, dated August 27, 1981.

Upon due notice, a prehearing conference was held on August 3, 1981 and thereafter, continued until September 3, and then September 11, 1981. On September 11, 1981, Intervenor filed a Position Statement of Intervenor State of Hawaii. Thereafter, at the prehearing conference conducted on September 11, 1981, Petitioner asked for a continuance of the proceedings to reevaluate its position in light of the Intervenor's response.

On October 20, 1982, Petitioner filed a Motion to Withdraw Petition for Declaratory Ruling with this Board. The affidavit of HGEA's counsel, Bruce M. Ito, indicates that the withdrawal is sought because the matter is being pursued administratively.

Good cause appearing therefore, the Board hereby grants HGEA's motion to withdraw.
