On October 14, 1982, Respondent STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS [hereinafter referred to as SHOPO], by and through its legal counsel, filed a Motion For Extension of Time to File Respondent's Exceptions to Proposed Findings of Fact, Conclusions of Law and Order. By its motion, SHOPO requested an extension of time from October 18, 1982 until October 25, 1982. In a supporting affidavit, counsel stated he was conducting research with respect to the Exceptions to Proposed Findings. By Order No. 459, said motion was granted.

Thereafter, on October 22, 1982, SHOPO filed a second Motion for Extension of Time to File Respondent's Exceptions to Proposed Findings of Fact, Conclusions of Law and Order seeking an extension of time from October 25, 1982 to November 1, 1982 or until such time as the Board deemed appropriate. In a supporting affidavit, counsel states he has been unable to complete the research and drafting of Exceptions to Proposed Findings of Fact, Conclusions of Law and Order due October 25, 1982 because of the unanticipated length of arbitration hearings conducted during the week of October 18, 1982. Counsel also states that said Exceptions will be ready for submission no later than November 1, 1982.

The Board hereby grants SHOPO's motion for extension of time from October 25, 1982 until November 1, 1982. Based upon counsel's representation in his affidavit that said Exceptions will be completed by November 1, 1982, no further extensions will be granted.
