ORDER DENYING PETITION FOR INTERVENTION

On November 8, 1982, George R. Ariyoshi, Governor of the State of Hawaii, Eileen R. Anderson, Mayor of the City and County of Honolulu, Eduardo E. Malapit, Mayor of the County of Kauai, Herbert R. Matayoshi, Mayor of the County of Hawaii, and Hannibal Tavares, Mayor of the County of Maui, by and through their respective legal counsel, filed with this Board a Petition to Intervene in the aboveentitled case.

Pursuant to due notice, this Board conducted a hearing on the petition on November 16, 1982 in the Board's hearings room. Upon consideration of all argument presented with respect to this petition, the Board hereby denies the Petition for Intervention.

Petitioners have expressed their concern about the hearings officer's recommended remedies in this case and its potential economic impact upon the Public Employers and the public, in general. As the Petitioners' arguments regarding their contractual interests are premised upon the unsuccessful ratification of the tentative agreement, such concerns are premature and speculative at this point. Petitioners have thus failed to demonstrate that they have any statutory or other legally assertable interest which would justify granting them intervenor status in these proceedings. Should the Board impose remedies which may adversely impact upon them, there are adequate legal procedures by which Petitioners may seek redress. Accordingly, the Petition for Intervention is denied.

However, the Board will permit Petitioners to submit further oral and written commentary in future proceedings on an amicus curiae basis.
