ORDER GRANTING PETITION FOR INTERVENTION

On December 27, 1982, Eileen R. Anderson, Mayor, City and County of Honolulu [hereinafter referred to as City], filed with the Hawaii Public Employment Relations Board [hereinafter referred to as Board] a Petition for Intervention in the above-entitled case.

On January 10, 1983, Petitioner HAWAII GOVERNMENT EMPLOYEES' ASSOCIATION [hereinafter referred to as HGEA], filed with this Board a Motion Objecting to the Petition for Intervention. HGEA requested that the Petition for Intervention be denied inasmuch as City positions are not in controversy and thus the City's intervention would unduly broaden the issues presented and would unduly delay the proceedings in the instant case.

After due notice, a hearing was held on the motion on January 25, 1983, where the HGEA agreed to amend its Petition for Clarification or Amendment of Appropriate Bargaining Unit filed on December 1, 1982, to include, in

addition to the previously named 109.5 State positions, 49 City positions to be reviewed by the Board to determine if the positions' continued exclusion from collective bargaining is warranted.

On January 26, 1983, the HGEA filed its Amended Petition for Clarification or Amendment of Appropriate Bargaining Unit with this Board to include the 49 City positions.

Accordingly, inasmuch as the City has alleged a sufficient interest for its participation in the proceedings, the Board hereby grants the subject Petition for Intervention pursuant to Administrative Rules §12-42-8 (g) (14).
