ORDER APPROVING RESPONDENT'S  
SUBMISSION OF RATIFICATION PROCEDURES

On March 14, 1983, pursuant to Decision No. 170 in this matter, the STATE OF HAWAII ORGANIZATION OF POLICE OFFICERS [hereinafter referred to as SHOPO] filed with this Board its procedures governing the ratification of the collective bargaining agreement covering the period July 1, 1981 through June 30, 1983. The submission includes procedures to notify bargaining unit members of the ratification vote, procedures governing ballot distribution and the conduct of voting in private, and the availability of union officials to respond to questions.

On March 16, 1983, SHOPO filed a Supplement to Respondent's Submission Pursuant to Decision No. 170 which includes the specific dates, times, and locations for the ratification voting (except for the island of Hawaii), the absentee ballot procedures and procedures regarding the tallying of votes.

We are also informed by SHOPO that the ratification voting on the island of Hawaii will be conducted as follows:

Thursday, April 7	Yano Hall	Captain Cook	0700-1200
Thursday, April 7	Thelma Parker Library	Waimea	1400-1700
Friday, April 8	Conference Room, Bldg. A	Hilo Police Station	0730-1630

As the procedures submitted by SHOPO, as modified above, are timely and conform with the Board's Decision in this matter, the procedures are hereby approved.
