On September 20, 1984, this Board issued a Notice of Receipt of Petition for Clarification or Amendment of Appropriate Bargaining Unit; Notice of Deadline for Filing Petitions for Intervention. The notice indicated that interested persons wishing to intervene in these proceedings must comply with Administrative Rules § 12-42-8(g)(14) and file a Petition for Intervention by October 1, 1984. On September 27, 1984, Russell K. Okata filed a Petition for Intervention on behalf of the Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO [hereinafter referred to as HGEA].

After a review of the Petition for Intervention, the Board finds that the HGEA, as the exclusive representative of Unit 4, has alleged a sufficient interest pertinent to the issues presented to be granted intervenor status. Pursuant to Administrative Rules § 12-42-8(g)(14), HGEA's Petition for Intervention is hereby granted.
