ORDER GRANTING MOTION FOR PARTICULARIZATION

On October 21, 1985, Respondents GEORGE R. ARIYOSHI, Governor of the State of Hawaii; FRANK F. FASI, Mayor of the City and County of Honolulu; DANTE CARPENTER, Mayor of the County of Hawaii; HANNIBAL TAVARES, Mayor of the County of Maui; and TONY KUNIMURA, Mayor of the County of Kauai [hereinafter collectively referred to as Respondents], filed with this Board a Motion for Particularization of the Complaint together with the affidavits of counsel of the individual Respondents.

Upon review of the aforesaid motion and affidavits and the charges set forth in the complaint, the Board concludes that

particularization of the complaint as requested in the Respondents' motion should be granted pursuant to Administrative Rules § 12-42-45(b).

The Board directs the above-named Complainant to file with this Board the original and five (5) copies of the requested particularization with proof of service upon Respondents, no later than 4:30 p.m. of the fifth working day after service of this order. The particularization shall provide particulars pertaining to that portion of the allegations of the complaint which alleges that "Respondents have unilaterally prepared plans, schedules and procedures which would modify and/or terminate existing rights. . .contrary to the provisions of the collective bargaining agreement." The particularization shall also enumerate the contract provisions which Complainant alleges have been violated by Respondents.

If Complainant fails to timely file and serve the particularization, the Board shall dismiss the subject prohibited practice complaint.

Respondents are directed to file with this Board the original and five (5) copies of the Answer, with proof of service upon Complainant, no later than 4:30 p.m. of the fifth working day after service of Complainant's particularization. The failure of Respondents to timely file their Answers shall constitute an admission of the material facts alleged in the complaint and particularization and a waiver of a hearing.
