ORDER GRANTING MOTION TO CONTINUE HEARING

On January 30, 1986, STANLEY GONSALVES, Complainant in Case No. CEE-01-1 and the UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO, [hereinafter referred to as UPW] Respondent in Case Nos. CE-01-96, CU-01-49 and Complainant in Case No. CEE-01-1 filed a Motion to Continue Hearing with this Board. The motion


For good cause shown, the Board hereby grants GONSALVES and UPW's Motion for Continuance of the Hearing.
