ORDER GRANTING PETITIONS FOR INTERVENTION

Takahashi, Esq., filed with the Board a Petition for Intervention in the above-entitled case. For good cause shown, the Board hereby grants the respective motions for extensions of time within which to file motions to intervene. The motions should be filed with this Board by 4:30 p.m. on July 8, 1987. However, as counsel for Hannibal Tavares has indicated that he is unable to file such motion by July 8, 1987 without undue hardship, he may file his motion to intervene by 4:30 p.m. on July 10, 1987.
