ORDER GRANTING MOTION TO CONSOLIDATE CASES FOR DISPOSITION
AND ORDER GRANTING MOTION TO CONTINUE PREHEARING CONFERENCE

On October 15, 1987, the HAWAIIAN MILLING CORPORATION filed unfair labor practice complaints against RAYMOND CARDUS [Case No. 87-12(CEE)], ANTHONY SEDENO [Case No. 87-13(CEE)], RONALD JOSEPH [Case No. 87-14(CEE)], EDGARDO FUENTES [Case No. 87-15(CEE)], ROBERT LOSCALZO [Case No. 87-16(CEE)] and WAYNE MIYASHIRO [Case No. 87-17(CU)] alleging violations of Sections 377-6, 377-7(6) and 377-8, Hawaii Revised Statutes [hereinafter referred to as HRS], as appropriate. The complaints arise from incidents occurring on or about September 30 and October 2, 1987, involving alleged mass picketing and obstruction and interference with the ingress and egress to Complainant's establishment.

On November 17, 1987, Respondents, by and through their attorney, moved to consolidate the six unfair labor practice complaints for disposition.

As these complaints involve substantially the same parties and issues, the Board finds that consolidation of the proceedings would be conducive to the proper dispatch of business and the ends of justice and will not unduly delay the proceedings. Pursuant to Administrative Rules Section 12-41-11, these complaints and the proceedings thereon are hereby consolidated for disposition.

In addition, on November 17, 1987, Respondents, by and through their attorney, move to continue the date for the Prehearing Conference from November 18, 1987 to November 25, 1987 at 10:00 a.m. In his supporting affidavit, Respondents' counsel stated that a continuance was necessary because of other pressing matters and that he had contacted the attorney for Complainant HAWAIIAN MILLING CORPORATION who had no objections to the continuance.

For good cause shown, the Board hereby grants Respondents' Motion for Continuance of the Prehearing Conference.

YOU ARE HEREBY NOTIFIED that the Prehearing Conference on the instant complaints is continued until November 25, 1987 at 10:00 a.m. in the Board's hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii. Pertinent provisions of the notice issued on November 2, 1987 remain applicable.
