ORDER GRANTING PETITIONS FOR INTERVENTION  
AND NOTICE OF PREHEARING CONFERENCE

On August 26, 1987, this Board issued a Notice of Receipt of Petition for Declaratory Ruling; Notice of Deadline for Filing Petitions for Intervention in the above-entitled case. The deadline for filing Petitions for Intervention was set at 4:30 p.m. on September 4, 1987.

Pursuant to such notice, on September 1, 1987, the United Public Workers, AFSCME, Local 646, AFL-CIO [hereinafter referred to as UPW], by and through its representative, Herbert R. Takahashi, Esq., filed with this Board a Petition for Intervention. Thereafter, on September 4, 1987, the Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO [hereinafter referred to as HGEA], by and through its representative, Guy T. Tajiri, and the University of Hawaii Professional Assembly [hereinafter referred to as UHPA], by and through its representative, T. Anthony Gill, Esq., filed their respective petitions to intervene in these proceedings.

As the filing of these petitions was timely and the UPW, HGEA and UHPA have alleged sufficient interests for their participation in the proceedings, the Board hereby grants the subject Petitions for Intervention pursuant to Administrative Rules § 12-42-8(g)(14).


YOU ARE HEREBY NOTIFIED that the Board will conduct a prehearing conference in this matter on January 15, 1988 at 9:30 a.m. in the Board's hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii. The purpose of the prehearing conference is to determine the positions of the parties and determine the necessity for a hearing or establish an appropriate briefing schedule.

All parties have the right to appear in person and to be represented by counsel or other representative.
