
ORDER GRANTING MOTION TO WITHDRAW

On February 25, 1988, Petitioner ALFRED LARDIZABAL, Director of Personnel Services, State of Hawaii, filed a Motion to Withdraw Petition for Declaratory Relief with this Board. The motion indicates that the withdrawal was filed on the grounds that the same issue was presented to the Circuit Court which ruled in Petitioner's favor. In addition, the Circuit Court decision was being appealed and would be reviewed by either the Intermediate Court of Appeals or by the Hawaii Supreme Court.

venors and good cause appearing therefore, the Board hereby
