ORDER GRANTING PETITIONER'S MOTION TO CONTINUE HEARING

On September 9, 1988, Petitioners filed a Motion to Continue Hearing with this Board. In its motion, Petitioners moved for a 30-to-60-day continuance of the hearing on Intervenor UNITED PUBLIC WORKERS, AFSCME, LOCAL 646, AFL-CIO's [hereinafter referred to as UPW] Motion to Defer to Arbitration Award and to Dismiss Petition for Declaratory Ruling presently scheduled for September 21, 1988. Counsel for Petitioners indicates in his attached affidavit that there are scheduling conflicts which prompt his request for continuance.

On September 12, 1988, Herbert R. Takahashi, Esq., counsel for Intervenor UPW indicated by letter that his client

had no objection to continuing the hearing but requested that the continuance not be for an extended period of time.

For good cause shown, the Board hereby continues the hearing on Intervenor UPW's Motion to Defer to Arbitration Award and to Dismiss Petition for Declaratory Ruling until October 28, 1988 at 9:00 a.m. in the Board's hearings room, Room 203, 550 Halekauwila Street, Honolulu, Hawaii.

Any written arguments in opposition to Intervenor's motion should be filed with the Board by 4:30 p.m. on October 25, 1988.
